

Partnership Agreement

Party A Details (such as Name, Address of Office)

- 1. The institution agrees to partner with WASH to implement the WASH platform and services. The partnership aims to create a safer, more inclusive campus environment.
- 2. The agreement will be valid for a period of one (1) year from the date of signing. Either party may terminate the agreement with written notice of thirty (30) days. The Contract can be renewed before 1 month from the date of the c
- 3. WASH will provide the institution with access to the WASH platform (Annexure 1), including reporting tools (Annexure 2), awareness campaigns (Annexure 3), and training programs (Annexure 4). WASH will conduct a comprehensive survey and campus analysis, provide customized content and materials, and deliver stakeholder workshops. Report to be shared with the Institution as well.
- 4. WASH retains all intellectual property rights under Trademark of the Logo, Slogan and Domain Name to the WASH platform and services. The institution agrees not to license, assign or transmit any WASH materials without prior written consent.
- 5. Both parties agree to maintain the confidentiality of the information such as the details of the students, the complaints, the sensitization mechanism, the workshop and training details shared during the partnership.
- 6. WASH complies with the Digital Personal Data Protection Act, 2023, and Information Technology Act 2000 for the storage of Digital Information and Website and App compliances. The institution agrees to provide WASH with necessary information (Annexure 5) to ensure compliance.

7. The institution agrees to pay WASH an annual subscription fee of ₹1,80,000.00. ₹90,000.00 to be paid

within thirty (30) days from the time of entering into the Contract, rest ₹90,000.00 to be paid after 3

months from the date of the initial payment. Invoice of such payments shall be provided to the institution,

as soon as the such payments are made, via email of the WASH.

8. The institution represents that it has the necessary authority to enter into this agreement. The institution

also needs to submit an affidavit of such capacity to enter in a partnership agreement, the affidavit must

also clarify that the rules and regulations of the institution are in compliance with the policies of the

WASH.

9. WASH will not be liable for any damages or losses arising from the use of the WASH platform and

services. The institution agrees to indemnify WASH against any claims or damages arising from the

partnership.

10. WASH will take the full responsibility of the information shared by the institution.

11. This agreement will be governed by and construed in accordance with the Indian Contract Act, 1872,

Prevention of Sexual Harassment at Workplace Act 2013, The Arbitration and Conciliation Act, 1996.

12. Any disputes arising from this agreement will be resolved through Mediation in accordance with the

Arbitration and Conciliation Act, 1996.
